1 Applying for your Electrical Permit

In Washington, only licensed electrical contractors may perform electrical work. Property owners may apply for an exemption from these requirements by completing this application and signing the affidavit below **before** beginning electrical work:

- Complete **all** sections & mark the applicable fee item(s) on the Fee Worksheet.
- After receiving your **completed** paperwork and payment we will issue a permit valid for 1 year.
- Permits can also be purchased online at www.ElecInspect.Lni.wa.gov

- Existing residential property, place of business or farm.** I, personally, and/or a regularly employed employee(s) will be doing the electrical work.
- 501(c)(3) or nonprofit religious organization owned property:** The total market value of electrical work must be \$30,000 or less and all electrical work will be performed by appropriately certified electricians or certified and properly supervised trainees who are volunteering and not being compensated for electrical work per RCW 19.28.091(7).
