¹Cutting vents into an existing roof is the work of roofers and carpenters, except for metal roofs; Sheet Metal Workers cut into sheet metal roofs; Ironworkers cut into metal roofs for packaged, pre-engineered metal buildings; Roofers may remove, but not install or repair metal roofs. If the work involves more than passive ventilation, i.e., an electrical fan, an Inside Electrician may also be required.

²Carpenters may install battery powered detectors only, (not hard-wired); Electronic Technicians and Inside Electricians Install hard-wired systems.

³Glaziers install or remove glass and similar materials in windows, doors, etc., and may install metal window and door frames and perform certain other tasks for door and window installation and repair. They do not install non-metal door and window frames.

⁴Roofers may remove, but not install or repair metal roofs. Sheet Metal Workers install and repair metal roofs; Ironworkers install and repair metal roofs on packaged, pre-engineered metal buildings.

⁵Sheet Metal Workers applies only if the installation is part of furnace installation/replacement.
