#### Department of Employment Security

Written report provided.

#### Department of Enterprise Services

Charles Wilson introduced himself at apologized for the lack of reports in the past due to a retirement in the agency. He announced the newly hired Contracts Manager would be providing the report in the future.

### **Department of Transportation**

Michael Carpenter, announced \$1.5 million was received from the legislature to create a Maritime Trades Preparation Program, which has a planned release an RFP in early May. \$750,000 was also received to create a Safe and Welcoming Work Site Program and they hope to release an RFP in early June. New funding has been received for the On-the-Job Training Support Services Scholarship Program.

### **Office of Superintendent of Public Instruction**

Roger Rich, Program Supervisor gave an update on E2SSB 5600; by December 1, OSPI must submit a report to the legislature, detailing the requirements and options for any barriers to high schools, in this state having a Career Pathways Day once a year, for students in their junior year of high school, including the recommendations of necessary legislative actions. This would include apprenticeship. Additionally by December 1 OSPI & L&I must submit a report to the legislature to identify opportunities and challenges for expansion, enhancement, and sustainability of high-quality career and technical education.

### **Oregon State Apprenticeship and Training Council**

Lisa Ransom reported when compared to Quarter 1 of 2021 there was a 50 percent increase in new apprenticeship registrations. To date they have 156 programs and 5,531 Training Agents.

### **State Board for Community and Technical Colleges**

Danny Marshall announced Jan Yoshiwara would be retiring in July after thirty plus years of working within the college system. The fall quarter had a 7.75 increase from the previous year. Danny reported tremendous growth in the Job Skills Program and has awarded out \$7.6 million dollars in the last year.

### **U.S. DOL, Office of Apprenticeship**

Corinna Pereira, Multi-State Navigator said the Apprenticeship Building America Grant Program grant applications are due April 25. She also said the Apprenticeship Ambassador Initiative has been released.

### **Washington State Apprenticeship Coordinators Association**

Jeremy Clevenger talked about the RSI Review and CRRS Committees and what they do for programs across the state and the benefit of attending them are. Taimarie Adams with Merit gave a presentation about online credentialing for Apprenticeships and how it can benefit and help apprentices in our programs grow in their reach for documentation.

### **Secretary, Washington State Apprenticeship and Training Council**

Celeste Monahan reported Director Sacks issued an order upholding the Council's decision to deny CITC of Washington's first proposed Standards for Mechanical Insulator. He also issued an order dismissing the appeal from Brinderson LLC regarding the Council's denial of Brinderson's request to waive the six-month rule for issuing Certificates of Completion. The Department hired Shawn Snyder effective February 16 for Region 5. She thanked all the sponsors who have provided committee member qualification forms for their committee members. Department staff are working diligently to prepare for and publish more than \$8 million in funding opportunities

### **WSATC Childcare in the Trades Subcommittee**

Shana Peschek reported with additional funding they received they will be offering two trainings as well as written materials being sent directly to apprentices from L&I.

Chair Kommers called a break at 9:58a.m. The meeting reconvened at 10:17a.m. and Chair Kommers confirmed all members of the council were present.

### **WSATC CTC Policy Review Subcommittee**

Chair Kommers said he has appointed himself as the Interim Chair and asked the Department to set up their first meeting in June to talk about the mission of the committee.

### **WSATC Electrical Subcommittee**

Steve Harper, reported they have updated the language on the MGS and asked for approval to amend the Minimum Guideline Standards. **M/S/C** to approve the amended language. Steve said Registered 01 Apprentices are allowed to work with a 02 or 06 if they don't have the 02 or 06 occupations as Registered Apprenticeship.

### **WSATC Reciprocity Subcommittee**

Member D'Hondt asked the council to extend the current reciprocity arrangement until October 2022 WSATC meeting at which time the California and Nevada program may request reciprocity by responding to the criteria as outlined in 296-05-0113. **M/S/C** to approve. He also asked the Department to convene a meeting with Nevada & Oregon after the one-year mark of the signing of the Tri-State Agreement.

The subcommittee will be meeting monthly to meet the deadline for this bill to be implemented by July 1, 2023.
