## **DEFINITIONS**

- Work-related musculoskeletal disorders (WMSDs) conditions that disturb or disrupt the functions of the musculoskeletal system, and are caused or exacerbated by work. These conditions typically affect soft tissues such as joints, nerves, tendons, ligaments, muscles, blood vessels, cartilage, or spinal discs. WMSDs are generally caused by work activities that are repetitive, require forceful exertion, expose the worker to vibration, and/or involve awkward postures and unnatural positions of the worker. For more information on the identification of WMSDs in the workers' compensation data, see SHARP WMSD case definition technical report.
- **All other claims** includes any claim not classified as a WMSD.
- State Fund the State Fund is Washington State's workers' compensation fund. Washington is an exclusive workers' compensation state, meaning all employers in the state must obtain workers' compensation coverage from the State Fund unless they are covered by an alternate system (e.g., the federal government, employers of railroad and long-shore workers), are specifically exempted in WA Statute (e.g., the self-employed), or self-insure. Washington State does not allow private carrier workers' compensation coverage. The State Fund insures approximately 75% of employed workers in Washington.
- **Self-insurance** employers that self-insure for workers' compensation coverage in Washington must meet financial requirements, including net worth or revenue minimums and a demonstrated safety organization with a record of accident prevention (RCW 51.14.030/WAC 296-15-021). Approximately 25% of covered Washington workers are employed by self-insured employers. Data on time loss and claim costs are limited for self-insured claims.
- Medical aid claim claims for less severe work-related injuries or illnesses, only qualifying for reimbursement of medical treatment costs.
- Wage replacement or disability claim claims for more severe work-related injuries or illnesses, and qualifying for additional compensation beyond medical costs, including time-loss compensation, permanent disability awards, kept on salary, survivors' benefits, funeral expenses, and/or pension benefits. To qualify for this additional compensation, the injured worker must have been medically certified as unable to perform normal work duties beyond a three-calendar day waiting period not including the day of the injury.
- North American Industry Classification System (NAICS) NAICS is the US national standard for classifying industries. It is a hierarchical system, with increasing specificity as the number of digits in the codes increases. Industry sector is 2-digit code, industry group is the 4-digit code, and industry is the 5-digit code.
- Washington risk class Risk class is the system in Washington for which workers' compensation premiums are determined. All employers in Washington are assigned risk classes, for which they report hours into quarterly. Risk classes are designed to classify hours worked into groups based on injury or illness risk and financial risk.

#### **EXECUTIVE SUMMARY**

Work-related musculoskeletal disorders (WMSDs) are frequent and continue to account for a substantial portion of Washington's total costs to workers' compensation each year. Workers' compensation claims for WMSDs continue to decline in Washington State, following similar trends previously described\*. WMSD claim experience is not uniform across industries; we identify trends and other differences by industries here.

#### **Key Findings:**

- WMSDs account for one-third of all wage replacement or disability claims. WMSD costs the State Fund approximately 27% of medical aid claim costs and 45% of wage replacement or disability costs.
- State Fund medical aid rates decreased similarly for WMSD claims and all other claims, an estimated 3-4% decrease each year between 2006 and 2019. For State Fund wage replacement or disability rates, WMSD claims decreased at a statistically significant faster rate than all other claims—an estimated 5.3% versus 3.4% decrease each year, respectively.
- Self-insured wage replacement or disability claim rates decreased at slower rates than State Fund claims. Self-insured wage replacement or disability rates decreased an estimate 1.6% for WMSDs, and 1.7% for all other claims each year.
- The decline in claim rates is not the same across industries or risk classes, with no decline or increases in rates among specific industries/risk classes.
  - Medical aid WMSD claim rates statistically significantly increased among the following Washington risk classes in the State Fund: "Orchards", "Inmates – Prison Industries", and "Vineyards".
  - Wage replacement or disability claim rates statistically significantly increased among the following self-insured Washington risk classes: "Home Health Services and Nursing Care, N.O.C.", "Meat Products Mfg./Slaughter and Packing Houses", "Fruit/Vegetable Canneries/Food Product Mfg., N.O.C.", "Temporary Help Assembly", "Motels and Hotels", "Temporary Help Warehousing", "Meat, Fish, and Poultry Dealers Wholesale", "Clerical Office, N.O.C.", and "Non Wood Frame Building Construction".
- Additionally, the Prevention Index rankings identified industries and risk classes most in need of
  WMSD prevention. Examples of high-ranking risk classes include the following: State Fund "Nursing
  Homes", State Fund "County and City Fire Fighters Salaried", and self-insured "Scheduled Airlines –
  Flight Crew". Similarly, NAICS industry groups in most need are the following: State Fund "Nursing
  Care Facilities" and "Foundation, Structure, and Building Exterior Contractors", and self-insured
  "Scheduled Air Transportation".

## **TECHNICAL NOTES**

#### Inclusion criteria

All accepted claims for WMSDs with a date of injury between 2006 and 2019 were considered for inclusion, queried in January 2022. State Fund and self-insured claims are presented here separately. Claim data for this report was retrieved on 04-28-22.

#### Exclusion criteria

Rates among risk classes or NAICS industries with fewer than 17 claims for the three year period from 2017 – 2019 are not displayed because they are not considered reliable, i.e., the Relative Standard Error (RSE) is above 25%.

#### Rate calculations

Claim rates are presented here for the combined time-period of 2017 through 2019 for a current estimate, and by year from 2006 to 2019 for trend analyses. For all rate calculations, the number of claims is divided by the number of reported hours to the workers' compensation system and displayed as claims per 1,000 FTE (2,000 reported hours = 1 FTE).

#### Claim cost and time loss estimates

Claim costs and time loss were estimated for all claims using the costs and time loss days paid to date for closed claims, and case reserve forecasts for open claims as of January 2022. Closed claims may be re-opened in the future, so costs are not necessarily final. All costs presented here were adjusted for inflation to reflect 2019 dollars using the Consumer Price Index. Median time loss days are presented among claims with any time loss greater than 0 days.

#### Trend analyses

Claim rate trends were analyzed using negative binomial regression analyses, controlling for number of hours reported. A trend or change in rate is considered statistically significant when the P value was less than 0.05.

#### Prevention Index ranking

The Prevention Index (PI) ranking is a method of ranking industries or risk classes to identify those most in need of intervention. The industry or risk class with the PI ranking of '1' is considered most at risk. The PI ranking takes both number of claims and claim rate into account: PI = (count of claims rank + claim rate rank)/2.

## **RESULTS**

# Burden of work-related musculoskeletal disorder (WMSD) claims

Between 2017 and 2019, approximately 18% of all State Fund medical aid claims and onethird of all wage replacement or disability claims (State Fund and self-insured) were due to work-related musculoskeletal disorders (WMSDs).

Work-related musculoskeletal disorder claims account for approximately 27% of the total costs for medical aid claims, and 32% of wage replacement or disability claim costs in the State Fund each year.

# Work-related musculoskeletal disorder (WMSD) claim trends

The State Fund medical aid claim rates significantly declined during 2006 through 2019, with WMSD and "all other" claim rates decreasing at similar rates.

Figure 1. Washington workers' compensation claim rates per 1,000 FTE for WMSD and "all other" claims, State Fund medical aid only, 2006–2019.



The State Fund wage replacement or disability claim rates significantly declined during 2006 through 2019, with WMSD rates declining at a faster rate than "all other" claim rates.

- Nursing Homes
- Warehouses, N.O.C., Grocery Dist. & Recycle Centers
- Boarding Homes and Retirement Centers

State Fund risk classes with statistically significant increasing WMSD medical aid claim rates:

- Orchards
- Vineyards
- Inmates Prison Industries
