Your responsibilities — Getting started

As an employer, state law requires you to:

Follow the safety and health core rules. These are the basic workplace safety and health rules most employers in Washington State must follow. They are available online at www.Lni.wa.gov/Safety/Rules/chapter/800. You may also request a CD copy of the core rules by calling 360-902-5521. These core rules address:

- Employer responsibilities for safe and healthy workplaces
- Required written accident prevention program and safety meetings/committees
- Personal protective equipment
- Chemical hazard communication

There are other rules that businesses may have to follow and those can be found at www.Lni.wa.gov/Safety/Rules.

Follow the rules for specific hazards in your workplace.

Along with the core rules, other safety and health rules may apply to your industry — for example, the construction work safety rules in Chapter 296-155 WAC or the noise rules in Chapter 296-817 WAC.

Keep your workplace free from recognized hazards that are likely to cause serious injury or death.

What is DOSH?

L&I’s Division of Occupational Safety and Health (DOSHS) is the state equivalent of OSHA. In Washington State, DOSHS is responsible for workplace safety and health rules.



We offer many services to help you protect your employees and comply with workplace safety and health rules.

How we can help

L&I's Division of Occupational Safety and Health (DOSH) can help you protect your employees from work-related injury or illness.

To request a no-fee workplace safety/health consultation, sprains and strains assessment or risk management assistance, call the DOSH consultation manager for your area. (See numbers below.)

- **Safety and health consultation:** Find and fix hazards through an on-site consultation; review your written accident prevention program with a professional.
- **Sprains and strains assessment:** Sprains and strains are the most common type of workplace injury in most industries. Learn how the design of workstations, work practices and work flow (also called “ergonomics”) can create the best fit between people and their work — avoiding risk factors for sprains, strains and other injuries.
- **Risk management assistance:** See the connection between safe, healthy workplaces and your profits. Understand how injuries and occupational illnesses affect workers’ compensation premiums, claim-free discount, and other business costs.

Worker death or hospitalization

Employers: Notify L&I within 8 hours if a work-related death or inpatient hospitalization occurs. An amputation or loss of an eye(s) of any employee must be reported within 24 hours of the incident. However, if the amputation or loss of an eye(s) requires in-patient hospitalization or results in a fatality, follow the 8-hour reporting requirement.
