

## Worker Killed in Equipment Rollover



### What happened?

A firefighter suffered fatal injuries when the snow cat all terrain vehicle (ATV) he was operating rolled several times, crushing him between the cab and ground.

The firefighter was driving the ATV while another firefighter in the passenger seat used a fire hose to extinguish a wildland fire. The 1970s vintage ATV had been modified by firefighters into a mobile firefighting apparatus with a water tank, gasoline motor and water pump on its back deck.

The firefighter who was driving was trying to go up a steep hill with a 19-degree slope. After a few attempts, the ATV's treads slipped on loose rock, the firefighter lost control and the vehicle tipped, rolling several times downhill about 100 feet.

The ATV was equipped with rollover protection and seat belts, but neither firefighter was wearing a seatbelt. Both were thrown from the vehicle. The passenger survived but the driver was killed.

### What can you do to prevent a fatality from happening at your workplace?

- Wear seat belts when riding in or operating a vehicle.
- Make sure any modifications to equipment are allowed by the manufacturer.
- Familiarize yourself with the safe operation of the vehicle you will be using.
- Train workers to operate the equipment assigned to them.
