MEETING CALLED TO ORDER @ 9:02a.m. by Chair Newgent

ROLL CALL: Present: Lee Newgent, Ed Kommers, Dave D'Hondt, Jeff Johnson, and Ron Storvick. **Absent:** Pat Perez, Leslie Jones.

GREETINGS: Mark Manzel, Executive Director Cascadia Technical Academy, greeted the council and the audience. The Cascadia Technical Academy serves about 1,200 students each year in 16 programs. We offer a wide range of programs including aviation, dental, diesel, and culinary. The students spend a half a day in their assigned high school and half a day in their program. This results in 70 percent of kids going into the industry or postsecondary education and very low unemployment rates.

SPECIAL REPORTS:

Registered Youth Apprenticeship Presentation: Kristi Grassman, Director of Pre-Apprenticeship, AJAC Manufacturing Academy/K-12; Reported two models are currently operational, one in Tacoma at Lincoln High School and one in Yakima. At Lincoln High School, the RSI takes place after school on Tuesdays and the OJT is on the weekend. The Yakima school has added apprenticeship to their Core Plus School and RSI & OJT take place during the day. All the employers are excited to be part of the program.

Caroline King, Chief Policy and Strategy Officer, Washington STEM: Reported over the next five years one third of the job openings will be in the STEM industries. There are ten regional community-based networks which connect employers, educators, and community organizations around common goals. We are trying to bring the Youth Apprenticeship model to other places where we have networks.

John Aultman, Senior Policy Advisor, The Governor's Office; Stated we are transitioning from having a high school diploma and your A.A. through Running Start to having a high school diploma and a journey level card. We are looking forward to the next five to ten years.

Workforce Training and Education Coordinating Board

Dave Pavelcheck, Deputy Director of the Workforce Board, stated they are implementing the State Strategic Plan. This plan aims to integrate how a wide range of Workforce programs are delivered to people so the lines between programs and agencies are not barriers to getting people served quickly.

Secretary, Washington State Apprenticeship and Training Council

Elizabeth Smith, Assistant Director, Fraud Prevention and Labor Standards, stated there is one Training Agent Compliance case involving a ratio and supervision issue. On the Vertical Options Apprenticeship Program, the Director denied the appeal and the permanent registration of the Vertical Options Apprenticeship Program stands. On I.E.C. of Washington, the Director has issued his Final order denying I.E.C.'s appeal. Welcome to Jim Kaltenbaugh, our Technical Specialist, and Evan Hamilton, Apprenticeship Consultant 3 in Tumwater. The Apprenticeship Utilization Requirement Task Force has completed their survey about Apprenticeship Utilization Requirements and we will be reviewing the results with the Committee in May.

Steve Harper, Southwest Washington JATC, Todd Turner, Inland Empire Electrical Apprenticeship; Stated the Electrical Standards Subcommittee developed guideline standards for 01, 02 and 06 occupations and is now being sunsetted.
