

I-BEST	 Washington's Integrated Basic Education Skills Training (I-BEST) certificate programs incorporate Basic Education classes into post-secondary training. I-BEST is an instructional model designed to better support students to degree completion. To be approved by SBCTC, I-BEST offerings must contain college-level credits and demonstrate a pathway to an approved one-year certificate and beyond. See diagram below for comprehensive definition of I-BEST pathway. 	I-BEST accepts students at an ESL level 3 or above. I-BEST is one pathway for adult basic Education (BEdA.)
