Process

- 1 Eligible reciprocal states:
 - **Oregon** – those who completed an 8000-hour apprenticeship to become a General Journeyman Electrician (J) and General Supervising Electrician License holders are eligible.
 - 2 Before submitting application, review all rules, qualifications and reciprocal agreements: Information regarding reciprocal agreements is available at <https://www.lni.wa.gov/licensing-permits/electrical/electrical-licensing-exams-education/electrician>
 - 3 Application must include all required additional documents. Incomplete applications will delay the process. If filling in form by hand, please print using blue or black ink.

Qualifications

You may be eligible to reciprocate if you have:

- 1) Qualified for a licensing exam in the reciprocal state through completion of required work experience; and
- 2) Obtained the license or certificate you are reciprocating through examination by a eligible reciprocal state, and
- 3) A license from a reciprocal state that is current and active with no violations or conditions attached within the past three years; and
- 4) Not failed the Washington examination for the license type you are reciprocation with the past two years; and
- 5) Qualified as allowed by a reciprocal agreement and reciprocal rules.

Reciprocal agreements may not include all allowances in [WAC 296-46B-940](https://www.lni.wa.gov/licensing-permits/electrical/electrical-licensing-exams-education/electrician).
