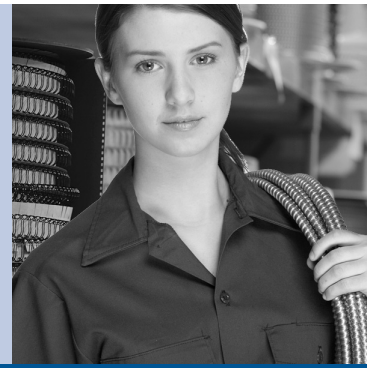


Wãwein Jumae Kãlet eo an Ra eo an Labor & Industries Ikijen Claim eo am



Ta melele in Jumae?

Kwōj jumae ilo am kwalok ilo leta ke kwōjjab errã ibben kãlet eo ear kōmman ñan claim in jãan in jibañ ñan ri jermal ak workers' compensation. Kwōj aikuj in jilkintok leta in jumae eo am loan 60 raan jen ien eo kwar loe leta eo kin kãlet eo.

Leta in jumae eo am ej aikuj in wōr melele kein:

- Etam im numba in claim eo am.
- Raan eo Ra eo am ear kōmane kãlet eo an.
- Wūn eo wūnin am jab errã koba jabdewōt report ko jen taktō ak mejele ko jet kwōj tōmak ke rej kwałok bwe jemłok eo ejjab jimwe.

Ta eo enaaj walok ñe Ra eo enaaj loe leta in jumae eo aō?

Claim menija eo enaaj etale file in claim eo am im enaaj kōmane juōn iaan men kein:

1. Ukōt kãlet eo kar moktata. Kwōnaaj loe juōn leta kãal ak order, ak men kein jimor, ibben kãlet kãal eo.
2. Kalikkar ñe ejimwe kãlet eo kar moktata. Kwōnaaj loe juōn order ej kwalok ke kãlet eo ejimwe. Kwōmãroñ jumaeiki order in ilo am jeik juōn leta ñan Board of Industrial Insurance Appeals

(BIIA) elañe kokabde jab errã. Joñan aitokin raan ko ñan am uak im mailing address eo ñan am jumae enaaj bed ilo order in.

3. Kalikkar elañe ej aikuj wōt melele. Kwōnaaj loe order eo im ej kwalok ke emōj kabōjrak kãlet eo, leta eo ej kajjitōk bar jet melele, ak men kein jimor. Claim menija eo emãroñ kajjitōk bar jet melele jen kwe, taktō eo am im jikin jermal eo am.

Emãroñ bōk 30 ñan 60 raan ak aitok lak ñan an wōr kãlet kãal ñan jumae eo am elañe rejjab bar aikuj melele ko jet. Ñe kwōjañin droñ uak loan 30 raan elikin am jilkinlok leta in jumae eo, jouj im kirlok claim menija eo am.

Ak ñe ijab jumae ak appeal, ak ñe ikōmane elikin 60 raan?

Ñe kwōjjab jumae ak appeal loan 60 raan, kãlet eo kar moktata an Ra eo eban oktak. Melele in ke **kwōjjab mãroñ jumae ak appeal kãlet eo bar juōn ien tokelik.**

Ñe ewōr aō kajjitōk ak abunōnō kin claim eo aō, wōn eo ij kirlok?

- Claim menija eo ej lorlorjake case eo am, ikijen kajjitōk ko rej jelete claim eo am. Claim menija eo am emãroñ kappok am ri ukook Kajin Majōl ñan jibañ ilo ien am kenono ibben.
- Namba eo an Ra eo ilo ejelok wōnãan ej 1-800-547-8367, ñan melele ko ekkã aikuji. Namba in ej bar lewaj melele ko ilo Spanish.
