


Ni gute wagaragaza ko utishimiye icyemezo Minisiteri y'umurimo n'inganda yafashe ku kirego cyawe



Kugaragaza ibyo utishimiye ni iki?

Kugaragaza ibyo utishimiye ni ibaruwa ivuga ko utemera icyemezo ku kirego cyawe cyerekeye guhemba abakozi. Ibyo utishimiye bigomba kwakirwa mu minsi 60 umaze kwakira icyemezo.

Ibyo utishimiye bigomba kuba bikubiyemo:

- Izina ryawe na nomero y'ikirego cyawe.
- Itariki icyemezo cya minisiteri cyafatiweho.
- Impamvu utemera icyemezo kongeraho na raporo z'utanga serivisi cyangwa andi makuru utekereza ko agaragaza ko icyemezo cyafashwe atari cyo.

Ni he nshobora cohoreza ibyo ntishimiye cyangwa ubujurire bwanje?

Bigenda bite iyo Minisiteri yakiriye ibyo ntishimiye?

Ushinzwe ikirego cyawe asuzuma dosiye y'ikirego cyawe maze agakora muri kimwe mu bikurikira:

1. Guhindura icyemezo cyari cyafashwe. Uhabwa ibaruwa nshya cyangwa iteka rishya, cyangwa byombi, bikubiyemo icyemezo gishya.
2. Kwemeza niba icyemezo cyari cyarafashwe ari cyo. Uhabwa iteka rivuga ko icyemezo cyari cyo. Ushobora kujuririra iri teka rishya mu nyandiko bigashyikirizwa Board of Industrial Insurance Appeals (BIIA) iyo ucyumva ko utabyemera. Igihe na aderesi yoherezwaho ibaruwa y'ibyo ujuririra biba biri ku iteka.

3. Kwemeza niba hakenewe andi makuru. Uhabwa iteka risaba ko icyemezo kiba gisubitswe, ibaruwa isaba andi makuru, cyangwa byombi. Ushinzwe dosiye yawe ashobora kugusaba andi makuru, kuyasaba muganga ukuvura, cyangwa umukoresha wawe.

Icyemezo cyerekeye ibyo utishimiye gishobora gufata iminsi kuva kuri 30 kugeza kuri 60 cyangwa irenzeho hashingiwe andi makuru akenewe. Iyo udahawe igisubizo mu minsi 30 nyuma yo cohoreza ibyo utishimiye, ubimenyesha ushinzwe ikirego cyawe.

Bigenda bite iyo ntagaragaje ibyo ntishimiye cyangwa kujurira, cyangwa nkabikora nyuma y'iminsi 60?

Iyo utagaragaje ibyo utishimiye cyangwa kujurira mu gihe cy'iminsi 60, icyemezo cya minisiteri kiba ari ndakuka. Bivuze ko **udashobora kugaragaza ibyo utishimiye cyangwa kujuririra icyemezo itariki yarenze**.
