


Ow fi Protes a Depawtment a Layba & Indusstrees Dicishon pon Yu Klame



Wha iz a protes?

A protes iz one letta weh seh yu nuh gree wid di dicishon pon yu werkas' compinsayshon klame. Wi muss git yu protes widin 60 dayz a yu receet a di dicishon.

Yu protes affi ave inna it:

- Yu nayme an yu klame numba.
- Di dayt a di depawtment's dicishon.
- Di reesen yu nuh gree wid it ploss ani providas' riport ar anneda infamayson yu tink seh show seh di dicishon did wrang.

Weh mi fi sen mi protes ar apeel?

- Sen di protes pon line an youz di Klame an Akount Centa a www.Lni.wa.gov/Secure (yu aguh kneed fi sit up one akount wid one passwud fi youz di ya apshon). AR
- Sen one writtin protes tu: Department of Labor & Industries, P.O. Box 44291, Olympia WA 98504-4291. AR
- Sen one writtin apeel tu di Boadd a Indusstreal Inshoranse (Board of Industrial Insurance, BIIA), Eggzecutiv Sekitry (Executive Secretary), P.O. Box 42401, Olympia WA 98504-2401, or submitt yu apeel pon one elektranik farm yu can fine a www.BIIA.wa.gov. (Layba & Indusstrees nah guh fi bi aybl fi adress yu koncern onles dem git awda fi duh suh bi BIIA.)

Wha happin wen di dipawtment receive mi protes?

Yu klame maniga a guh revue yu klame an a guh du one a di fellahin:

1. Chang di orijinal dicishon. Yu a guh receive one nue letta ar awda, ar boat, wid di nue dicishon.
2. Dicide di orijinal dicishon iz carreck. Yu a guh receive one awda weh a seh di dicishon waz carreck. Yu maa apeel dis nue awda inna riting tu di Boadd a Indusstreal Inshoranse Apeels (BIIA) if yu stil nuh gree wid it. Di tyme fraym an mayling address fi di apeel wil deh pon di awda.

3. Dicide moor infamayshon iz kneedid. Yu a guh receive one awda plasin di dicishon pon ole, a letta a guh awsk fi sum moor infamayshon, ar boat. Di klame maniga a guh reuess moor infamayshon fram yu, yu dackta, ar yu emplaya.

One dicishon pon yu protes cud tek 30 tu 60 dayz ar langa bass pon wedda moor infamayshon iz needed. If yu nuh receive nuh respanse inna 30 dayz afta yu sen een yu protes, pleez contact yu klame maniga.

Wha if mi nuh protes ar apeel, ar du suh afta 60 dayz?

If yu nuh protes ar apeel widin di 60-dayz peerod, di depawtment's dicishon iz final. Dis meen seh **yu caan protes ar apeel di dicishon lata on.**

If mi ave quesston ar koncern bout mi klame, whoo mi shouda contact?

- Di klame maniga whoo a andlin yu kase, fi quesston spicifik tu yu klame. Yu klame maniga ave akses tu interpritas fi assiss wid di kall.
- Di depawtment's tol-free numba, 1-800-547-8367, fi general klame infamayshon. Di numba pruhvide one apshon fi ear infamayshon inna Spanish.
