- 1) Ma jiro loo shaqeeye eryi kara ama qaab kastaba ku takoori kara loo shaqeeye kasta sababtoo ah loo shaqeeyahan waxa uu soo xereeyay ama cid kala xidhiidhay ujeedada soo xaraynta cabasho magdhow ah ama ku dhaqanka xuquuqo kasta oo lagu siiyay hoosta cinwaankan. Si kastaba ha ahaatee, ma jirto qaybtan wax ku jira oo ka hor istaagta loo shaqeeye inuu wax tallaabo ah ka qaado shaqaalaha iyaddoo sababo kale ah ay ka mid tahay, laakiin aan ku xadidnayn ku guul daraysiga shaqaalaha inuu dhowro caafimaadka ama heerarka badbaadada ee uu sharciga ka dhigtay loo shaqeeyahu, ama inta jeer ama sifada shilalka shaqaalaha ee shaqada la xidhiidha.
- 2) Shaqaale kasta oo rumaysan in isaga ama iyadda la eryay ama haddii kale uu takooray loo shaqeeyahu iyaddoo lagu xad gudbayo qaybtan waxay ku soo xarayn karaa cabashada maamulaha takoorka lagu andacoonayo gudaha **sagaashan maalmood laga bilaabo taariikhda xad gudubka lagu andacoonayo**. Marka la helo cabashadan, maamulahu waxa uu bilaabi doonaa baadhitaan in la sameeyo, sida uu maamulahu u arko inay habboontahay.
