# Agenda Item 1 – Approval of Agenda

# **Public Hearing**

Start of Public Hearing at 10:20 am.

The proposed rules include:

- WAC 296-104-010, Administration What are the definitions of terms used in this Chapter?
- WAC 296-104-700, What are the Fees and Expenses

Called to order at 10:20 am by Tim Barker, Chair and serving as a representative of Insurance companies. He is also serving as the Hearing Officer.

Introductions are made. Pamela Nelson is the court reporter from Capitol Pacific Reporting. Tim Barker provided summary of proposed rules.

The rulemaking proposes amendments to the Boiler rules under chapter 296-104 of the WAC.

- The amendments affect the definitions and fees for boilers and pressure vessels.
- The proposed amendments modify the definition of pool heaters to clarify that pool heaters
  without shut off valves on the discharge side are considered open to atmosphere and therefore
  exempt from inspection requirements.
- An increase in fees for inspections and other boiler and pressure vessel program services by 6.41% in fiscal year 2026.

The amendments are needed to ensure the inspection requirements for pool heaters are clear and that fees will support the boiler program's operating expenses.

The Department evaluated the potential economic impact of the proposed rule on small business and the cost of rule versus its benefits.

- It was determined that neither a small business economic impact statement nor a cost benefit analysis was required.
- This information is available on the CR102 proposed rulemaking form.

No attendees from the public present to attend. Brief recess is called to allow opportunity for other

members to join.

Return to public hearing at 10:35 am. No attendees testify. Public Hearing adjourned at 10:36 am.

# Agenda Item 5 - Review Extension of Inspection Frequency for DA1 Dearator Storage Tank

Tim Barker calls for representative from PCA to testify.

Ryan Ray from PCA identifies as representative.

The Request was discussed in the study session.

Ryan Ray provides summary of request.

PCA requests a six-month extension due to a short outage in April.

- Unable to take both DAs out of service and get them back up for the mills running.
- Plan to take number 2DA out of service for inspection this year.
- Number 1DA to be inspected end of April/first of May in 2026.

Request includes the storage tank and the DA heater.

PCA provided non-destructive examination results from May 2021 and April 2023.

• Corrosion rates indicate no concerns.

Tim Barker calls for a motion to approve the extension.

Keith Black motions to approve.

John Pittman Seconds the motion.

Tim Barker calls for a vote to approve. He also is abstaining from the vote as PCA is a client of his.

All board members vote "aye."

Motion passes.

# **Department notes**

Mike Carlson presented quarterly boiler program inspection information to the board.

Inspections completed from November 1, 2024- January 31, 2025

The following information is regarding current workload and overdue inspections in the Boiler program. Data collected 2/3/2025. Currently, there are:

**142** State Commissioned Inspectors

Inspections in the last quarter- November 1, 2024- January 31, 2025 171 Internal boiler inspections. (406) 2,004 External boiler inspections. (2,051) 11,740 Pressure vessel inspections. (12,188)

Total inspections =. **13,915** (14,646)

The Statewide overdue rate average is **7.9%** (9.8%) with **9,102** (11,462) (60 days or more overdue) without a valid certificate.

5,233 new objects have been added in 2024.

Current total of objects is **116,692** (116,718)

There were **581** violations opened, **133** were closed last quarter. (581,190)

Currently there are **345**-boiler, and **1,077**-pressure vessel violations open which totals **1,422**. (346, 1,053, 1,392)

One red tag violation opened last quarter. 1 (1)- pinhole leak on Air receiver.

Mike Carlson stated that he will help out and that anyone can go into the Governor's board to submit an application.

The next Board meeting will be May 7, 2025.
