

vi. All apprenticeship accounts with the JATC are paid in full.

vii. All apprentices must obtain a Class B Commercial Drivers manual transmission (no code "E" restriction) License within the first 1000 OJT hours of the registration date.

viii. All apprentices must obtain 1st Aid/CPR certification within 45 days of registration date, Traffic Control Flagger certification within 90 days of registration date, and Commercial Driver License Permit within 90 days of registration date.

- ~~8) All apprentices advancing from 3rd to 4th step must also receive a passing grade of 70% on the applicable Pesticide Certification test, as noted by the area of initial dispatch. Prior to completion of the program, all apprentices must have obtained the proper applicator license as dictated by the area of initial dispatch.~~
