- c. Heavy/Highway, and Utility Construction, and Renewable Energy
 - Pipe Laying operations: Installation of all cave-in protection systems, signaling/spotting for the excavator operator, signaling/spotting dump trucks, signaling/spotting backfill equipment, rigging pipe and structures for hoisting by the excavator, finding physical location of buried utilities fastening all pipe joint and components together grout mixing and application, concrete placement/consolidation, set-up and use of elevation control tools and technologies, perform hydrostatic test, low-pressure air test, chlorination of potable water pipes on systems installed by construction craft laborers.
 - The placement and testing of plastic conduit for electrical cable, when the conduit is buried underground.
 - Install and maintain erosion control systems.
