The Department will be filing a request to cancel the Apprenticeship program “Longworth Studio” at the upcoming July 17, 2025 due to non-compliance with CFR 29.29, RCW49.04 and WAC296-05. The Department has verified through the Washington State Department of Licensing that this is no longer an active business in the State.

What does this mean for you? The Department will be making the request for Cancellation to the Washington State Apprenticeship and Training Council at the July Quarterly Meeting. Following that meeting if the request is approved then the apprenticeship program will be cancelled by the Department effective July 17, 2025.

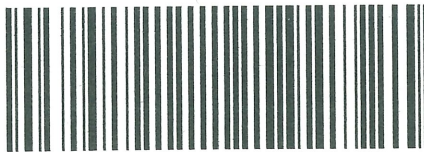
