Direct Access to Laborers Education and Careers (DALEC) would like to receive recognition from the Washington State Apprenticeship and Training Council for a new preapprenticeship program, DALEC.

We will be working with the Northwest Laborers Employers Training Trust through an Articulation Agreement to provide preparatory training for the NWLETT Apprenticeship program. The applicants will be selected from areas identified in Priority Hire Programs to provide opportunity to underserved communities. We will be reviewing previous applicants to the Laborers Apprenticeship and reaching out to the community to identify and interview prospective applicants to determine those that are the best fit for the NW Laborers Apprenticeship Program. The first week is about the physical nature of Laborers work, digging a trench, scaffolding, material handling etc. and is vital in identifying those that want to be there. Weeks 2 and 3 introduce them to the jobsite, nomenclature, safety, and other basic preparation for being onsite. Applicants will have to successfully pass all classwork and after doing so will be given direct access to the NW Laborers Apprenticeship.

Pre apprenticeship programs have been shown to increase graduation rates from Apprenticeship programs. They are also a vital tool to reach under-represented communities in the Building Trades that have been targeted in King County with Community Workforce Agreements at the City of Seattle, King County, Port of Seattle and other political subdivisions. We look forward to working with the JATC to provide opportunity for careers in the Building Trades.

## **ORGANIZATION DESCRIPTION**

- The DALEC program is a preparatory training for community members to enter the Northwest Laborers Apprenticeship Program.
- This program has partnered with Northwest Laborers Employers Training Trust ("NWLETT") to provide direct entry, through an articulation agreement, into the NWLETT Apprenticeship program for all successful participants.
- ➤ DALEC has contracted with NWLETT for the use of their American National Standards Institute (ANSI) Certified instructors, ensuring continuity and integration in the NWLETT Apprenticeship Program will be seamless.
- > Students will be selected from areas designated in Washington State to satisfy the needs of various Local Hiring Ordinances.
- > The goal is to reach underrepresented segments of the community to help fill the demand for Laborers and build lasting careers that will not only benefit the individual but the entire community.

#### **STUDENT ENTRY REQUIREMENTS**

- Potential students will meet the minimum qualifications (listed below) by applying to our program through NWLETT official application process.
- Upon acceptance into the program, each student will take and pass a drug screening provided by NWLETT

#### MINIMUM QUALIFICATIONS

- > 18 years of age or older
- > Tenth grade education or equivalent.
- ➤ Completion of NWLETT's NEA (New Entrance Exam). This will help gauge applicants' knowledge and score will not be used as a barrier.
- Current valid Driver's License
  - All potential applicants must demonstrate they have access to dependable transportation to arrive on all assigned job sites in a timely manner.

#### **COURSE DESCRIPTION**

Duration: 3 weeks (120 hours)

Area of Study:

- Job Site Safety
- Construction Math
- Blueprint Reading
- Grading

- Scaffolding Awareness
- Tool Recognition
- Tool Application

#### Certifications Received:

- Flaggers
- Powder Actuated Fastener
- OSHA 10
- CPR/ First Aid
- Bloodborne Pathogens
- Silica Awareness

#### Course Breakdown:

Week 1 (40 hours): Completion of NWLETT's Pre-Construction Training (PCT) course. This 32-hour course focuses on Scaffold Awareness, proper grading techniques and material handling. The tasks performed within these skill sets are used to determine if the student is physically capable to perform the duties of a Laborer. Completion of the flagger's certification course (8 hours).

Week 2 & 3 (80 hours): Participation in the General Construction course. This class focuses on Construction Math, Blueprint Reading, Tool Recognition and Application. During this course the students will receive training in proper use of Powder Actuated tools. The objective of these two weeks is to build the students confidence in the recognition and usage of the most common tools in the construction industry. Proper knowledge will increase of safety factor for the member and contractor.

- OSHA 10 (12 hours)
- CPR/ First Aid (8 hours)
- Silica Awareness (8 hours)

## Requirements for Completion

- ➤ All applicants must pass the PCT (Pre-Construction Training) course with a score of 80 points out of 100. This is the physical side of the application process that has been developed by NWLETT.
- ➤ Passage of the Flaggers certification course with a final test score of 80 percent or better. This class is given by a NWLETT instructor that is certified through Washington state to conduct the training.
- ➤ Must complete the required 120 hours of combined hands-on training and course work study.

Upon successful completion of the 120-hour training course, students will have direct entry into the Northwest Laborers Apprenticeship Program. At entry into the program the apprentices are eligible to take a dispatch from one of NWLETT's 600+ contractor training agents. The NWLETT apprenticeship program is a Washington State Registered Apprenticeship program consisting of 480 hours of related supplemental instruction hours and 6000 hours of on-the-job training.

## Demand for Program

Demand for skilled construction labor is here and on the rise. Need for these workers has been driven by local government, state government, federal government and WSDOT dollars to rebuild our states infrastructure which includes, but is not limited to schools, hospitals, roads, bridges, and buildings. Area work has also seen a huge upswing in private sector investment. Combination of these work sectors has shaped a perfect storm for creation of living wage jobs that programs like DALEC provide for our community.

## **Number of Students**

➤ The program will enroll 10-15 applicants per 3-week cohort.

➤ Laborers Local Union 242 has over 650 active Laborer apprentices currently registered with Washington State. Cohorts will be run on an as needed basis to ensure ample opportunity to active apprentices.


## Student Support, Retention and Success Strategies

- ➤ Classes will be run based on the schedule provided earlier. The structure of the class has been designed to best equip the students with the skills and work ethic needed to maintain employment.
- > Students will be referred to participating community-based organizations to determine their eligibility for benefits based on need.
- Apprentices are tracked throughout the program to ensure successful completion. Apprentices are required to complete weekly On the Job Training (OJT) hours slips and complete 80 hours of Related Supplemental Instruction (RSI) every 1000 hours as a checkpoint towards completion.
- Mentoring will be provided to ensure the Apprentices have guidance and access to community and union resources to help them overcome obstacles or barriers.

### <u>Outreach</u>

- ➤ Pre-apprentices will be recruited from statewide locations but will have an emphasis in low-income areas of King, Pierce, and Snohomish counties.
- ➤ Recruitment will be in the form of outreach opportunities, schools, job fairs, community events and other opportunities that present themselves.

- ➤ Reach out to applicants that have a valid application in with NWLETT that are on there waiting list.
- ➤ Work with community-based organizations to provide opportunities for clients that are interested in a career in construction.
