Liz stated one that's important to realize is Apprenticeship is a system that transfers knowledge and experience through guidance, mentorship, and classroom training, but it's fueled by passion.

Oregon State Apprenticeship and Training Council

State Board for Community and Technical Colleges

Dr. Genevieve Howard stated for the fall term of 2023 the Apprenticeship head count across the system was 8,723, this is a 7 percent increase from the same time the previous year. The Full-time Student Equivalent, or FTEs, is 4,387, this is an 11 percent increase from the same time the previous year. Dr. Howard said these data points indicate the CTC system continues to be available to meet the needs of RSI course demands for the Washington State Registered Apprenticeship Programs.

U.S. DOL, Office of Apprenticeship

A written report was provided.

Washington State Apprenticeship Coordinators Association

Jeremy Clevenger said the meeting was held at the Northwest Maritime Apprenticeship facility and a tour was given afterwards. Jeremy said during good of the order he brought up a question about how businesses reach out to him in regards of wanting to present their services about Apprenticeship to our Committee. He asked by a show of hands if anyone is interested in those types of presentations. The answer was the committee members are not interested in those types of presentations. Jeremy also stated the committee members would like training on how to access information on Labor & Industries webpages regarding apprenticeship meetings. Jeremy also made another request for the January meeting to be held virtually.

Washington Student Achievement Council

Heather Hudson said two pieces of legislation regarding the Washington College Grant relates to Registered Apprenticeship as well as the Native American Apprentice Assistance Program that WSATC will be administrating. Lyle Irinata said they have awarded over \$370,000 to about 125 apprentices for WG-A and another \$40,000 for Washington Bridge Grant. Karen Dove reported ANEW awarded \$119,000 to 28 apprentices in the last week.

Workforce Training and Education Coordinating Board

Anthony Whitesides reported the Workforce Board recently submitted the State Workforce Plan, Talent and Prosperity for ALL to the U.S. Department of Education and Labor for final approval. The Plan will guide Washington's workforce development strategy over the next four years. It also guides state and federal investments in our Workforce Development system, which totals \$1.4 billion a year in several programs who serve nearly 500,000 students and workers each year.

Secretary, Washington State Apprenticeship and Training Council

Secretary Monahan reported 17,480 active apprentices and 632 completion credentials in the last quarter. Monty Norris has joined the Department and will be focusing on Apprenticeship Preparation Programs on the west side of the state. Jody Robbins is leaving the agency and is taking on the role of State Director of Apprenticeship and Training in Oregon State. Celeste spoke about several grants including a grant for driver education that provides vouchers to minors age 16 to 17.

WSATC Childcare in the Trades Subcommittee

Shana Peschek reported on Imagine U that provide technical assistance to open new family home providers, which are the most flexible and easiest to do nonstandard-hour care. King County opened 25 new ones recently and another 100 will be open by June. Marianna Hyke is now the new Chair and the Vice-Chair position is still open.

WSATC CTC Policy Review Subcommittee

WSATC Electrical Subcommittee

Rob Bartel reported they have submitted a request to the Council to direct the Department to revise all minimum Guideline Standards to reflect the changes to the Work Processes. M/S/C to approve the changes. Rob also brought to the Councils attention how the subcommittee is functioning. It has grown from a small group, which would come to a consensus very easily to a larger group. Some guidelines will need to be given regarding voting, etc. Chair Riker stated he intends to engage in the construct of the Electrical Subcommittee back to functioning.

WSATC Industry and Economic Sector Platform Subcommittee

Jordan Shepherd reported the Department has begun the process of rule writing to extend the cutoff for submission for Quarterly Council Meetings from 45 days to 60 days. This will allow new programs coming into the system to receive feedback from the Industry Sector Platforms. Jordan asked for volunteers for the platforms, as more are needed.
