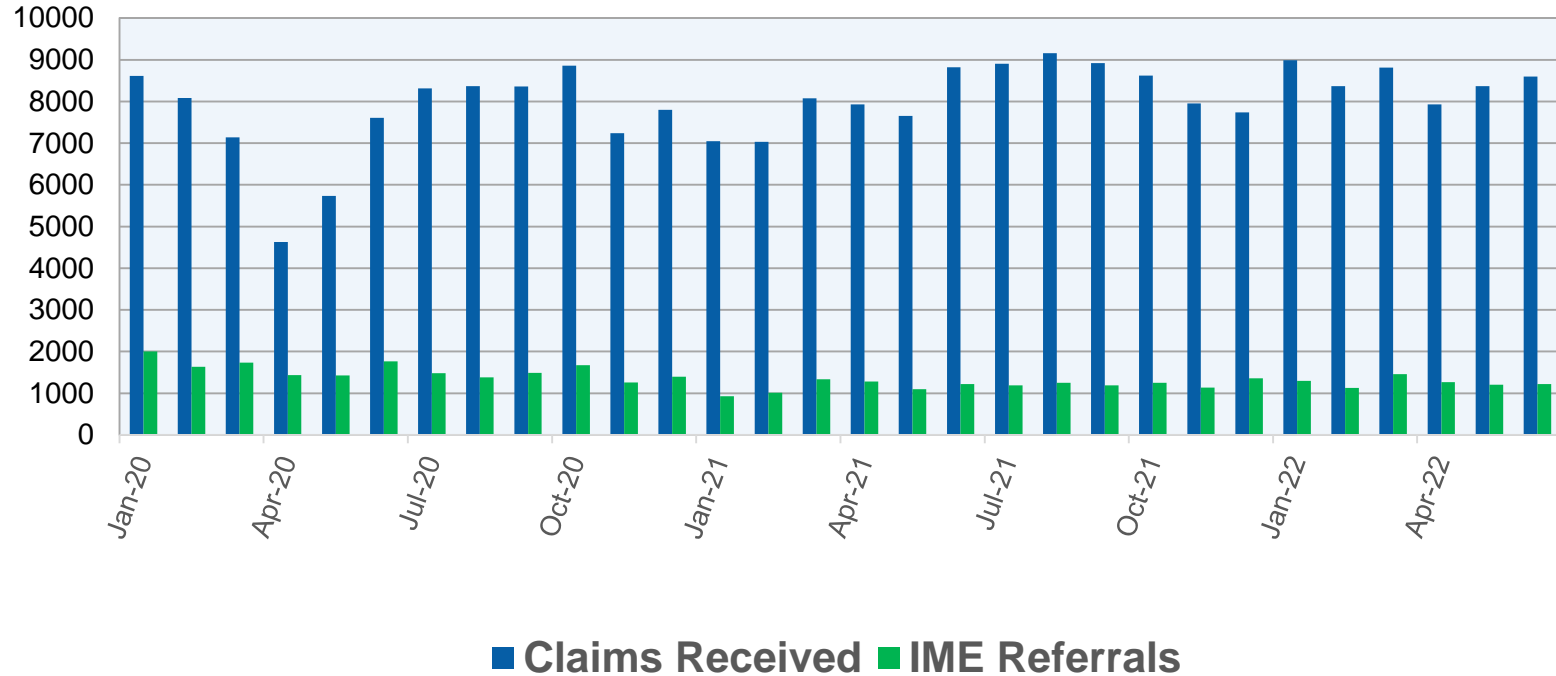

## New Claims and IME Referrals July 2019 - June 2022



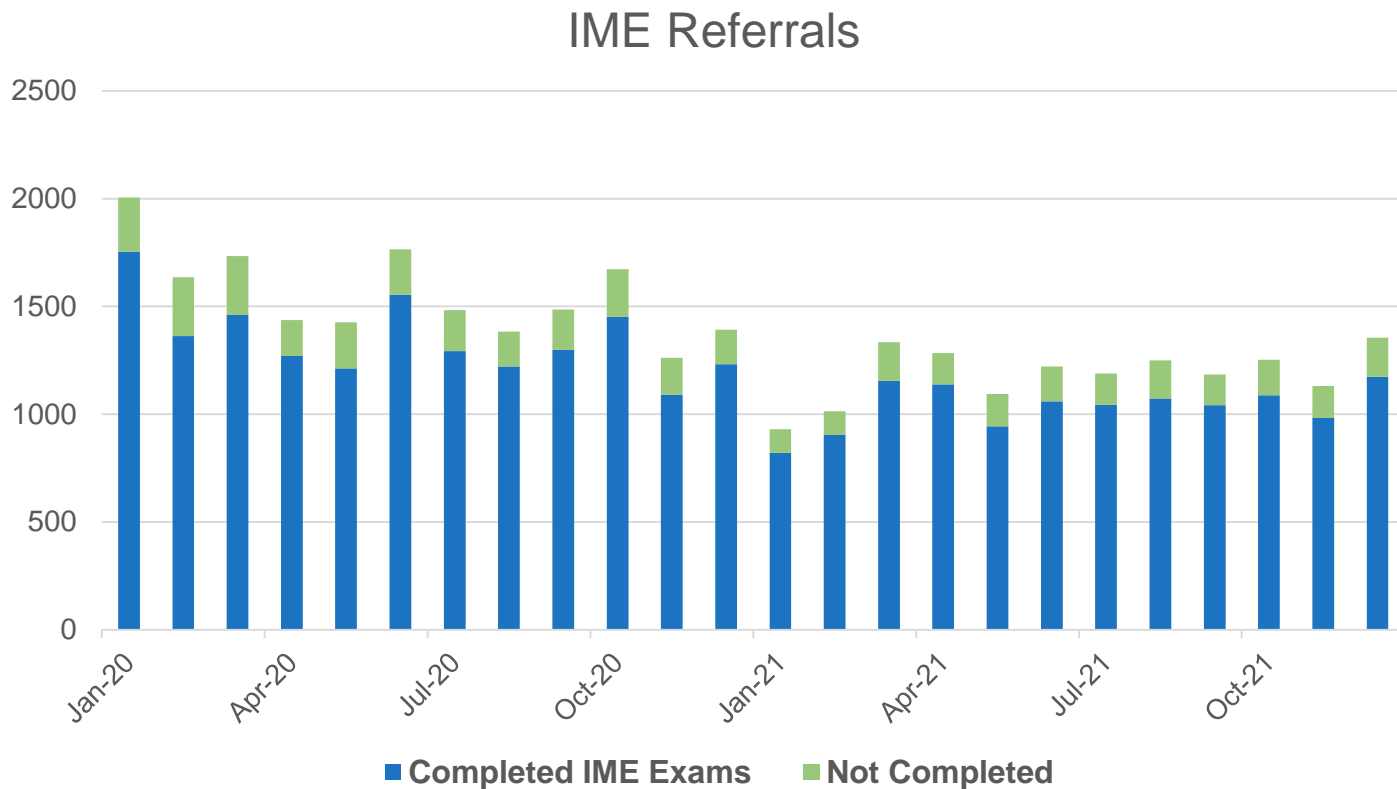
