IIMAC New Member Appointment (Andrew Friedman, Gary Franklin, Jennifer Jutte)

Jennifer introduced Dr. Dawn Ehde as the first psychologist member of IIMAC; her position starts October 2024. Dr. Ehde will also serve as co-chair on the PTSD subcommittee and was warmly welcomed by the committee.

Improving Quality of Care for Workers (Andrew Friedman, Kirk Harmon)

The committee discussed various ideas to enhance quality of care for workers. Suggestions included gathering data on the main causes of care delays, engaging with group A providers, and reviewing forms for potential, optimal changes.



PTSD Subcommittee (Stephen Thielke, Zach Gray, Jennifer Jutte)

Zach provided an overview of the PTSD subcommittee, including its background, mission, and composition, along with potential topics for discussion. The first meeting is scheduled for August 21, 2024, with the project expected to be completed in the later half of 2025.

Gary presented information findings on Neurogenic Thoracic Outcome Syndrome Surgery in Washington Worker's Compensation.

Updates

Medical Consultant RFQQ – Suzyn Daniel

The Medical Consultant RFQQ is now complete, with all bids closed. Bidders who have met the criteria will be notified soon. Not all specialties received bids, the Department is exploring opportunities to address these needs.

WCAC PTSD Subcommittee – Jennifer Jutte

Jennifer reviewed the goals and scope of the WCAC PTSD subcommittee, which includes examining PTSD claim data, researching prevention practices, and examining industry best practices. The first meeting took place in June 2024, where foundational concepts as well as claims and cost data were discussed. The next meeting date is yet to be determined, but future meetings will be held quarterly.

Post-traumatic Stress Disorder Survey and Jurisdictional Review – Amy Updike

Amy discussed the upcoming PTSD study which set is to be posted as a solicitation on WEBS around August 1, 2024. This study will include jurisdictional review related to PTSD.

IME Legislation- Nancy Adams

Nancy gave an update on the IME legislation:

- In 2021, ESSB 6440-limit on when and why an exam can be requested
- In 2023, SHB 1068- the right for workers to record exams, audio or video
