# Tree trimmer dies after falling from crane hook

A tree trimmer suspended from the hook of a crane was killed when his line detached, dropping him more than 70 ft to the ground below.

The tree trimmer had been using crane to reach a backyard area where limbs and tree sections couldn't simply be dropped. The crane would lift the tree trimmer to the higher parts of the trees where he would attach a wire rope choker to the trunk of the tree and lower himself to area he wanted to cut.

After the cut was made, the crane held the section of tree that was cut while the tree trimmer rappelled down to the ground. The crane would then swing the section of tree, limbs still intact, around to the front of the property where a chipper truck was stationed.

One of the trees could not be reached with the 102-ft crane boom, so the operator attached a 23-ft jib extension and reeved the hoist line through the jib's sheave.

The tree trimmer then attached his gear to the crane hoist line hook and was lifted by the crane and slowly swung over the house toward the target tree. When the victim was still about 20 ft from the tree, his line detached from the hook and he fell 70 ft, suffering fatal injuries.

#### WHAT CAN YOU DO TO PREVENT A FATALITY FROM HAPPENING AT YOUR WORKPLACE?

- Meet before working on a special hazardous operation to identify all hazards specific to the job. Create an accident prevention plan that includes a fall-protection work plan.
- Follow the manufacturer's instructions when lifting personnel with a crane. This model crane required an approved lifting basket.
  - Make sure all outriggers are fully deployed to prevent the crane from tipping over.

- Take these steps to help ensure a safe working environment
  - Follow all appropriate regulations when using approved personnel lifting baskets.
  - When it is allowable to lift workers by direct attachment to a crane's hook, make sure the worker is tied in with a climbing line and uses an arborist saddle secured to an anchor point on the boom line or crane.
